Q: What is your name?

A: Hammed Bello

A: The process of developing plans of action for the health sector. One of the speakers, Yinka, defined policy making as politics making, which was quite eye-opening.

A: Empowered - yes, at the very least I feel better and more capable than I did before the workshop.
